1. Apologies for absence

001/25 RESOLVED (a) That the above apology for absence be received and approved. (All in favour)

Items 7(a) and 7(c) – Cllrs. J. Macrae and C. Rossington – Residents of Warford Park.

3. Public forum for questions – No questions were presented by members of the public.

4. Cheshire East Ward Member Cllr. H. Moss – (Item moved to after item 10) Borough Councillor H. Moss reported that a quotation for white lining had been received and it was expected that the work would take place in the spring. Road and footway sweeping has been undertaken to collect leaves and other debris. There is increased gully emptying activity at present due to an increase in flooding events. Borough Councillor H. Moss intends to undertake a review of the area and report gullies requiring attention. The issues relating to the fence at Noonsun Corner are still subject to a legal dispute, therefore, no progress has been made to restore the verge. Matters are progressing in processing planning applications relating to the CPASE site.

- (e) **Barclays Bank** – It was reported that a response from Esther McVey MP, who had made representations to Barclays Bank plc and HM Treasury, advised that Barclays Bank plc was not willing to review the complaint. The Financial Conduct Authority had advised that the Financial Ombudsman does not consider complaints submitted by public bodies because they usually have more resources and legal expertise to resolve disputes through other means. The Financial Ombudsman's remit is defined by legislation, therefore, for public bodies to be allowed to bring complaints to the Ombudsman there would need to be a legislation change by Parliament.

- i. **24/4501/HOUS:** Merryford, Warford Hall Drive, Great Warford. SK9 7TR
Extension to balcony at the rear of the property with supporting square timber columns at ground floor and toughened glass balustrade at the upper level.

- ii. **24/4694/CLPUD:** 2 Noonsun Cottages, Pedley House Lane, Great Warford. WA16 7AS
Lawful Development Certificate for replacement of existing outbuilding.

010/25 RESOLVED (a) **That the following comments be submitted to Cheshire East Council in respect of application 24/4694/CLPUD: Great Warford Parish Council consider that the replacement timber out building with proposed flat roof profile on the same footprint is acceptable in principle as it will not be visible from the frontage due to the fence and hedge along the roadside. The Parish Council is, however, concerned that the fence and hedge, which will provide the screening, was subject to a previously submitted application (22/4139M). Application 22/4139M was withdrawn and it is understood that issues relating to the position of the fencing have not yet been resolved. The Cheshire East Council Strategic Transport Officer submitted comments to application 22/4139M which stated, "...the proposed fencing appears to be located in the adopted highway verge...", therefore, the current application could be considered misleading as the location plan appears to indicate the property boundary along the roadside. It is requested that issues relating to the fencing are resolved in**

order to ensure appropriate determination of the current application. (All in favour)

The Clerk reported that installation of speed indicator devices without permission from Cheshire East Council would give rise to increased liability to the Parish Council should any adverse event occur. It may also invalidate some insurance covers also leading to possible increased liabilities.
